This MOU entered in on 05/08/2019 by and between MVP Samaj's K.G.D.M College Niphad and S. K. PTI & Sports Academy, Niphad .The aforesaid Academy is here after referred to individually as Academy and K.G.D.M College as Niphad college.

1. Objectives MOU:-

- A. To promote and enhance the academic interest between college and Academy.
- B. To enhance the self employability among the students.
- C. Training in various types of Physical & Obstacles training
- D. Physical Training institute Visits and guidance.
- E. Interaction with faculty and staff through guest lecture.
- F. Campus placement as per the requirement of college students.
- G. To provide trained manpower from the Academy to the college.

2. Technical areas of collaboration:-

- a) A continuing the quality improvement program to improve the quality of teaching with Physical Training.
- b) To provide the academic interaction between the S. K. PTI & Sports Academy, Niphad and college for the students benefits.
- c) To Provide at the necessary help in organizing workshop /conferences and Physical training for the enhancement of skill in respect of faculty, staff and students of Niphad college.
- d) To provide the necessary support for the establishment of training and placement.
- e) Guidance for the infrastructure development of the Niphad college.

3. Proposed mode of collaboration:-

KGDM College Niphad and S. K. PTI & Sports Academy, Niphad collaboration through the following -

- A. Cooperation Promotion of education and training in the area of mutual interest.
- B. Any other appropriate mode of integration agreed upon between KGDM College Niphad and S. K. PTI & Sports Academy, Niphad plan will be worked by the college depending upon the availability of recourse.

4. Terms and condition:-

- a. The training of the Physical course should be borrowed by the college itself.
- b. For visit related to advice and consultancy, travel and other expenses of the teachers and student shall be reimbursed by Niphad College.
- c. Use of Academy resources and infrastructure can be allowed for the limited period of time and availability of Academy row material.
- d. Both KGDM College Niphad and S. K. PTI & Sports Academy, Niphad agree to help identify and invite the faculty members and researchers from the other institutes to participate in the conference, seminars training and short term courses conducted by the college.
- e. This MOU may be amended, renewed and terminated by mutual written agreement of the Academy at any time.
- f. Either Academy has a right to terminate this MOU up on 60 days prior written notice to the other institute.

5) Confidentiality:-

The KGDM College Niphad and S. K. PTI & Sports Academy, Niphad agree to hold in confidence al information data designed by the institute as being confidential which is obtained from either institute or created during the performance of the MOU and will disclose same to any third party without written consent of other institute.

6) Duration of MOU:-

This MOU unless extended by mutual written consent of the institutes shall expire in Three years (2019-20 to 2021-2022) after the effective date specified in the opening paragraph ,However, on review, the MOU shall be extended for another TWO years by Mutual consents.

7) Coordinators:-

The KGDM College Niphad designates the Coordinator of MOU as Prof. Lokesh M. Galadge Head of Physical Edu. & Sports Dept. and Mr. Satish Kharat for the S. K. PTI & Sports Academy, Niphad for implementation of this MOU.


8) Intellectual Property Rights:-

The Intellectual Property rights (IPR) that area arise as a result of joint research and collaborative activity under the agreement will be worked out on a case to case basis and will be consistent with officially laid down IPR policies of the two .i.e College and Academy.
